## 2017-2018 Harlandale Education Foundation (HEF) Scholarship

### Eligibility Guidelines

- ▶ Graduate from a Harlandale ISD high school.
- ▶ Complete all sections of this application.
- ▶ Apply for HEF Scholarship funds no later than (3) years following graduation.
- ▶ Show proof of full time registration at a college, university or technical school. -
  - ↳ Scholarship once accessed is good for one year
- ▶ **New Option: A One Time Only Option (first accessed semester only) part time hour 6-11 hours \$312.50**

### Application

- ▶ HEF Scholarship applications are available through the high school counseling office and at the HEF office located in the Harlandale College Cafe Building at 1502 Fitch St., San Antonio, Texas, 78211. Upon receipt of the completed application and verification of eligibility, applicants will receive a HEF Scholarship Award Letter from the Harlandale Education Foundation in your senior packet. 2017-18 HEF Scholarship applications are good for approximately one year from the date of high school graduation.
- ▶ 2017-2018 HISD graduates who do not access HEF Scholarship funds during the academic year following high school graduation may re-apply for the HEF Scholarship annually until June 30, 2021\*. Funding for post-graduation applicants is not guaranteed and is dependent on the availability of funds. Please note that most recent graduates will be granted priority funding status.

### Accessing the HEF Scholarship Award

- ▶ All HEF Scholarship funds must be accessed within one year of the initial processing date. **Example for accessing:** (a) Summer & Fall (b) Fall & Spring (c) Spring & Summer (d) Begin in Spring 2018, skip summer; and finish in Fall 2018 of same year that you started.
- ▶ This does not apply to the “One Time Only Option”

### \*Application processing deadlines:

**Summer I: June 6, 2018; Summer II: July 11, 2018; Fall Semester: September 15, 2018; Spring Semester: January 31, 2019**

The completed HEF application and all supporting documents must be submitted prior to the *application processing deadlines*\*. Supporting documents include:

- Proof of acceptance and full-time enrollment in post-secondary institution
  - FAFSA Student Aid Report (free download) for U.S. citizens if PELL Grant is **not** awarded.
  - TASFA Student Report for undocumented students- (Dream Act).
- ▶ Disbursements will be made directly to the college in two consecutive payments; however, second disbursements are dependent on students' submission of documentation to the HEF office prior to the processing deadlines. Second semester documentation requires verification of a 2.5 GPA (based on full time hours) for the first semester and full-time enrollment for the subsequent semester.
